E-money and purchased payment facilities (PPFs): how can and should they be regulated?

TOPIC OVERVIEW:

Australia's system for regulating electronic payments is complex and expensive. Advances in technology are also making it out of date. The Financial System Inquiry considered options and in its Report proposed reforms but how adequate are they, in light of probable future growth and technological developments?

In this presentation, Professor Ross Buckley will explain how PPFs are regulated in Australia today and will critically analyse the FSI recommendations. He argues that the stage is set for a rapid growth in e-money in one form or other in Australia in coming years and will propose reforms beyond those suggested in the FSI Report, to future-proof the regulation of our electronic payments system.

Ross Buckley is the CIFR King & Wood Mallesons, Professor of International Finance Law, and a Scientia Professor, at the University of New South Wales.

His principal field of research is international financial regulation, particularly, at the moment, the regulation of digital financial services. He co-edits the International Banking and Finance Law Series and the Global Trade Law Series of Wolters Kluwer of The Hague.

He has consulted to the US Department of Justice, the US Securities and Exchange Commission, the Asian Development Bank, the Indonesian Department of Finance, the Vietnamese Department of Commerce and the Australian Taxation Office as well as to banks and finance houses in Australia and abroad. He has twice been a Fulbright Scholar and many times a halfbright scholar.
